COMMUNITY NEWS

On April 1, it was discovered that the storage facility at the South Pool was broken into. The door appears to have been kicked in. Unfortunately, the drop basket was empty and we believe checks were stolen. We have filed a report with the Pima County Sheriff Dept. If you have any specific information regarding this incidence please call the HOA to get the report number and then call the Sheriffs dept. The last bank deposit was made on Thursday, March 26th, so if you have placed a payment in the deposit box between Monday, March 23 and Tuesday, April 1st and your check has **not cleared** the bank please call or email the HOA with your check number so we can verify if it has been stolen. If your check has been stolen you need to stop payment on your check immediately and tell your bank of the situation so they can watch for any suspicious activity with your account. The door has been repaired and we have placed a dead bolt on the door to prevent this from happening again. If you have any questions, please don't hesitate to contact us.

<u>COMPLIANCE</u> <u>NEWS</u>

Architectural Review forms are available on our website. If you are planning to paint your house, approved colors are also on our website. If you are keeping existing colors you do NOT need to request permission from the Board.

We really need a volunteer to head up a Compliance committee. This person would oversee CC&R enforcement and communicate with the Board regarding enforcement issues. We also need to recruit additional people to be on this committee. Please consider getting involved in YOUR community.

MONTHLY DUES

HOA monthly dues are \$22 a month. Assessments are due the 1st of every month, if payment is not received by the 15th it is considered late and a \$15 late fee will be charged. Homeowners are responsible to send in their monthly dues in a timely manner, monthly invoices are not sent out. However, statements are sent out

homeowners keep up to date on their account. A 10% discount is given to homeowners paying for a full year of assessments in advance. The yearly amount with the discount is \$237.60 and your account must be current to receive the discount.

BOARD MEETINGS

Board meetings are held the second Tuesday of every month. Our next one is April 14th. We meet at 7:00pm at the South pool (Albatross & Wood Owl). We have one available Directors position, if you are interested, just come to the next meeting.
