### Remodeling

If you are going to be remodeling the exterior of your home, changing paint colors, or making major changes to your front yard landscaping, make sure you notify the HOA first. The required procedures for submitting applications can be found in the CC&R's in Section 6.3. The **Architectural Review Application** can be found on our website. Or, just give us a call and we can mail you one. If you have any questions on the process, feel free to contact us. We'll be glad to help.

### Weeds

Weeds are the most common impairment to the overall look of our community. That's why there is almost always some mention of weeds in each newsletter. And, of course, we'll send out personalized reminders if we notice the weeds in your yard getting out of control. ☺

### Landscaping Gravel

All properties in the community should have landscape gravel in the front yard. If you don't have gravel or if your gravel is thinning, you can have some delivered fairly inexpensively. We are working to secure discounts from local suppliers. Check with us for details.

To do our part to help spruce up the neighborhood, we will be adding gravel to the curb strip along the drainage basin on Wood Owl and around the south pool curb line. If you need help with your landscape gravel, let us know. We'd be glad to help you find the best option for your yard and your budget.

## Patio wall repairs and paint

If your patio wall is damaged or needs paint, please make arrangements to get it repaired soon. If the damaged portion is a common wall shared with a neighbor, the repair costs are usually shared between the owners. For guidelines on cost sharing see Article V of the CC&R's. If you need further clarification on patio wall repairs or need help making the repairs, let us know. If you have already repaired your wall but haven't painted it yet, please take care of that final step soon.

## Six-foot Easement

You may have noticed throughout the neighborhood that most homes have about 6 feet off the street clear of landscaping. Our neighborhood was designed with a 6 ft pedestrian/utility easement off the street. Please keep this in mind when updating or cleaning up your front yard landscaping and keep the 6-foot easement unobstructed. Another advantage to keeping the easement clear is that guests will be able to park their car partially off the street in front of your home, which will help make our narrow streets safer by reducing congestion.

## Help with Yard Maintenance

If you need help with your yard, contact the HOA before fines are imposed so we can help you find the best options. We are working toward securing discounts from various vendors for things like weed spraying, landscape maintenance, gravel, patio wall repair and painting. If you know of someone you would recommend, let us know so we can get the word out. Here are a few suggestions so far:
