PARKING REMINDER

Just a reminder that parking is only permitted in the garage or on the concrete slab. If you have a temporary guest or need additional parking you may park temporarily on the street if the vehicle is pulled at least half way off the street into the 6ft pedestrian/utility easement. Also, for temporary guests it is helpful to the HOA to call and give us the vehicle description and license plate number. We often get complaints about congestion in the streets and safety concerns. Street congestion has been greatly reduced since we've been asking you to keep parked cars at least half way off the street. We appreciate your cooperation. However there are still several cars being left out in the street throughout the neighborhood. We will begin issuing parking warnings for those that may not be aware of this parking policy.

FIRE HYDRANTS

Please be careful not to park your vehicles in front of the fire hydrants in our community. We must leave them accessible to the fire department. The fire department needs to access them quickly in case of an emergency. To help remind people we will be placing friendly parking notices on any car parked or blocking a hydrant. It is our hope that this will raise awareness on our streets. Thank you for your cooperation in this matter.



MONTHLY DUES

HOA assessments are \$22.00 a month. They are due the 1st of each month and after the 15th there is a late fee of \$15. There is a 10% discount given if you prepay for the entire year. Statements are sent out for your review quarterly with the newsletter. To keep costs down we do not send out monthly invoices.

HOLIDAY DECORATING CONTEST

Don't forget about our holiday decorating contest that starts the day after Thanksgiving. In past years, our neighborhood has displayed great holiday spirit and I hope that this year is no different.
