State Statutes allows homeowners to place one political sign on their property no larger than 24 inches by 24 inches. County regulations allow signs on private property to be posted 30 days before an election, and the signs can stay as long as 10 days after the election. References: ARS Section 33-1808 C; Pima County Code 18.79.110 E 15
