We generally meet on the second Tuesday of every month at 7:00pm at the South Pool located at the corner of Albatross and Wood Owl Drive. Please feel free to come, your suggestions and ideas are always welcome.

### POOLS

There are two community pools. The North Pool is located on the corner of Kingbird and Blackbird Drive. The South Pool is located on the corner of Albatross and Wood Owl Drive. The pool rules are posted at both pools, please read them and familiarize yourself with them. No one under the age of 16 is allowed in the pool areas without adult supervision. The Board of Directors reserves the right to revoke pool privileges to persons violating the rules. The pool ramadas are available for pool parties. A refundable \$75 deposit is required. For more information please contact the HOA. You should have received a pool keycard at the time of closing, if you have not, please call and we can issue one. A pool agreement needs to be signed and also a \$50.00 deposit is required. There is also a \$50.00 replacement charge for lost cards.

### MONTHLY DUES

Monthly dues are \$22.00 per month. The dues are collected on an honor system so you will not receive a monthly bill. You will receive a quarterly statement to keep you updated on your account. Payment coupons are available at our website or on request for your convenience. Payment is due the 1<sup>st</sup> of every month. If payment is not received by the 15<sup>th</sup> of the month it is considered late and a \$15 late fee will be charged. Please make checks payable to TCCHOA. Checks and money orders are the only form of payment accepted. Please mail your payment to TCCHOA, 9410 N. Albatross Drive, Tucson, AZ 85742 or you may use the drop box located at the South Pool. You may pay your dues monthly, quarterly, or annually however, all dues must be paid in advance. If you should choose to pay annually, a 10% discount will be given.

## PARKING

There is no overnight parking on the streets. The CC&R's allow for cars to be parked only in the garage and on the concrete driveway pad. If you have visitors coming in for more than 24 hours and require additional parking please contact the HOA with the model and make of vehicle as well as the license plate number and how long they will be staying to avoid a notice of violation. If you or your guests need to park on the street temporarily, please pull at least half way over the curb to reduce street congestion. There is no parking in the yards for any reason. RV and boat parking is limited to 24 hours for loading and unloading purposes only. No utility trailers are allowed. The parking rules are strictly enforced and violators may incur fines up to \$25.00 per day.

## TRASH PICK-UP

You are responsible for arranging your garbage pick-up. You may choose any vendor you like. Trash containers are only allowed to be out the night before collection day and must be put away that evening. Trash containers are to be stored out of sight in your garage or in your back yard.

## MAILBOX KEYS

The HOA does not handle the mailbox keys. If you need assistance, please contact the Mountain View Post Office on Thornydale Road.

## CC&R'S and BY-LAWS

At the time of closing you should have received a copy of both documents. It is important to read these and understand them. At the time of your purchase you signed a document agreeing to abide by the rules and regulations put forth in these documents. If you need an additional copy, they are available through the HOA for a fee of \$5.00. If you are planning to rent out your property, you are responsible for providing your tenants with a copy of these documents and also for their compliance.
